

# PSCA Meeting Minutes

### Call to Order:

- The meeting was called to order at 7:05 PM by *Ricky*.

### Previous Meeting Minutes:

- The *March* meeting *Minutes* were emailed to *Board* members prior to the meeting.
- After reviewing, *Roy* motioned to accept the *March* meeting *Minutes*. The motion was seconded by *Wes* with all present in favor.

### Treasurer's Report:

- The *Treasurer's Report* was emailed to *Board* members prior to the meeting.

- *Ricky* informed those in attendance that he had recently been contacted by several shooters who informed him that at a recent registered shoot *Randy Shirk* was observed shooting targets both *left-handed* and *right-handed*. This transgression coming only days after the *PSCA Board* had voted to revoke its ban on *NSCA Classification Reviews* for *Mr. Shirk*. *Ricky* also commented that he had been in contact with *Mr. Shirk* who admitted committing the infractions. After a brief discussion, *Jeff* motioned that the *PSCA Board* rescind its previous decision and allow the *NSCA Classification Review* ban on *Mr. Shirk* to remain in place. Motion was seconded by *Wes* with all parties in favor. *Ricky* will contact the *NSCA* to inform them of the decision by the *PSCA Board*.

### New Business:

After an intense debate about how shoot dates are approved, *Ricky* said he would try to organize a meeting of club owner and representatives at this year's *State Shoot* to brain-storm new ideas for scheduling registered shoot dates. In the interim, *Roy* agreed to concede the date in conflict to *Seven Springs*. *Ricky* reminded the *Seven Springs*' representatives that they would need to pay their 2017 PSCA and NSCA dues prior to him submitting their 2017 registered shoot application to the NSCA.

- *Mike Brendle* informed those present that with *Buffer Creek* hosting this year's *SCTP PA State Shoot* on *Saturday, June 18<sup>th</sup>*, they were looking for trappers to work the shoot. *Mike* also stated that there will be two (2) rotations on *Saturday...9:00 AM* and *12:30 PM*, and that anyone that traps for the shoot will be allowed to shoot the course free of charge at the conclusion of the event. Additionally, there would also be practice day available on *Friday*. *White Flyer* has also donated hats and *Buffer Creek* is looking for any additional individuals or companies willing to donate items to be given away to the kids.
